### **Gambling harm on the Central Coast**

Gambling is ubiquitous in Australia, and pollies, pubs and clubs like to talk about it as an ordinary, legal and harmless activity. But gambling harms far more people than we realise, across all social, economic and ethnic groups. On the Central Coast, that means our local economy loses \$5.2million a week, through over 4,600 poker machines (double the number in all of Tasmania). Every day, \$17million is lost in NSW through poker machines, every single day of the year. The shame and stigma surrounding gambling addiction prevents people seeking help because they are too embarrassed to phone a counsellor, or they think they are the only person in trouble and they should just “gamble responsibly” and it will be OK. 75% of the world’s non-casino poker machines are in Australia. Half of them are in NSW. None of them are in Western Australia. NSW isn’t normal.



1. Wrack on the Boat ramps at Koolewong Foreshore Reserve. **ACTION: Dept. of Lands say that the members of the public may take away 20kilos a day.**
2. Glenrock Parade house 189. Rubbish effecting vehicle line of sight at Refuge Corner Glenrock Parade Koolewong. **ACTION: More items are building up, worries about the upcoming fire season, as Glenrock Parade is the only exit onto Brisbane Water Drive. Contact Council**
3. RMS Traffic Lights at Koolinda and Jirrah Ave Point Clare. **ACTION: RMS Peter Talbot says that work is to start late this year and a push for finish in January 2020.**
4. Confirm that lifts are to be installed for Equal Access to Point Clare Station. **ACTION: Enquiring of Liberal Delegate Sue Dengate Point Clare Station who advised that the station was to be step free access.**
5. Advertise for new Advertisers in our Newsletter. **ACTION: New advertiser Envirocentral Pest Control.**
6. Point Clare Community Garden-ask for more volunteers. **ACTION: Mention in the next Newsletter that more volunteers would be welcomed.**
7. Point Clare Community Hall Fire Exit concerns. **ACTION: Express to council**
